2022 Department 139th Annual Encampment

At the 138th Department Midterm virtual meeting called to order on November 13, 2021, notice was given for the date and location for the 2022 139th Annual Encampment to be May 14, 2022 at 1 pm at the McLean County Museum of History located at 200 North Main Street, Bloomington, Illinois. Reference Department Order #9, November 15, 2021.

By the authority vested in me as Commander of the Department of Illinois, Sons of Union Veterans of the Civil War, by the National Constitution and Regulations, the National Policies, and the By-Laws of this Department, it is hereby ordered as follows:

1. The 139th Annual Department of Illinois Encampment shall be in person with a limited number to be allowed to attend virtually per National C&R regulations Chapter II, Article III, Section 1 (a) that states: The Department Commander may allow a limited number of brothers to attend virtually. Note: Virtual option will be predicated on whether the Department Commander's laptop will connect on that day with the museum's Wi-Fi.

NOTE: Should pandemic restrictions on in-person meetings be reapplied within the State, subpart (b) shall apply: When a state of emergency exists as the result of a declaration by the President of the United States, the Governor of a State, Territory or Possession, or local government officials who have the authority to declare a state of emergency which prevents a department from meeting, the Department Commander may allow the Department to meet virtually through the issuance of a Department Order.

2. Credential Cards shall be required for voting by all delegates whether attending in person or virtually and a list of attendees from each Camp shall be compiled and sent to the Department Secretary at deptofilsec21@gmail.com in advance, no later than May 1, 2022. Selection of Camp delegates shall conform to the Department Bylaws, Article XII, Section 5.
3. Department Officers not able to attend shall submit their notice via e-mail to the Department Commander to be excused to bryner_camp67@yahoo.com no later than May 10, 2022.
4. All Camps and Department Officers shall submit activity reports via e-mail no later than May 1, 2022 to the Department Secretary at deptofilsec21@gmail.com with carbon copy e-mail to the Department Commander at bryner_camp67@yahoo.com. The Department Secretary shall distribute electronically.
5. Any items to be included on the published agenda should be submitted to the Department Commander no later than May 1, 2022 at bryner_camp67@yahoo.com. Late items may be brought up at the meeting.
